Position summary

The Project Clinical Officer will assist the Project Director in coordinating all aspects of reproductive (obstetric fistula) healthcare services within the project. With a focus on holistic patient care, the Project Clinical Officer will oversee the delivery of clinical services including but not limited to establishing clinical practice policy and protocols, individual/group supervision, case conferencing, quality assurance and improvement, reviewing treatment plans while setting the pace for a high-performance productive department.

Desired qualifications/education/experience and qualities

The applicant should have the following educational qualifications and experience:

- A) Senior Registered Nurse / Midwife, Bachelor's Degree in Medical sciences, Public Health or any other relevant area (Certificate in Reproductive Health and experience in Obstetric fistula will be an added advantage)
- B) At least3years' experience in Project Management in Reproductive Health or Obstetric care setting.
- C) Experience in project planning approaches especially within communities

- D) Experience in leading advocacy and working with important project stakeholders and partners
- E) Previous experience of delivering various capacity building methods such as training workshops for health care workers (CHW, RN/RM, doctors), and providing support supervision for health care workers
- F) Knowledge of working with persons with disabilities or other at-risk groups and experience on mainstreaming issues of gender, age, and disability into programming
- G) Good networking and communication skills
- H) English fluency, both written and verbal, is a requirement (Understanding of Hausa is an added advantage)
- I) Good analytical and problem-solving skills
- J) Have adequate knowledge of or experience working in the North Central and North Eastern geopolitical zones of Nigeria
- K) Computer literacy i.e. proficiency in relevant computer applications and databases with practical skills and experience required.
- L) Highly self-motivated, focused, disciplined professional with a drive and dynamism to work under pressure with competing deadlines, and possess the ability to make an immediate impact
